

# Cookies Policy – Briganti Advogados

## WHAT IS A COOKIE?

Acookieis a small file of letters and numbers downloaded on to your computer to access certain websites. Cookies, among other things, enable web servers to storestatefulinformation on the user's device or to track the user's browsing activity. Depending on the information they contain and the way you use your computer, can be used to recognize the user.

To improve the quality and security of the site. They have an expiration date that can range from the duration of the session to a certain future date from which they cease to function.

#### UTILITY OF COOKIES ON THE BRIGANTI ADVOGADOS WEBSITE

Briganti Advogados uses cookies to facilitate navigation on our website, for security measures and to obtain greater efficiency and customization of the services offered to users. Our website does not obtain any data about your name or surname, nor about the address from which you are connected. The information obtained is related to the number of pages visited, the language, the social network on which our news are published, the city to which is assigned the IP address used to sign in to the website, and the number of new users, the frequency and recurrence of the visitor, how long th visit takes, the browser, and the driver or type of terminal from which the visit is made.

We use these information to upgrade our web pages, identify new needs and evaluate the improvements to be made in order to improve serve users who visit us, adapting them, for example, to the most used browsers or terminals

## TYPES OF COOKIES USED BY BRIGANTI ADVOGADOS

The cookies used on the Briganti Advogados website are divided into:

- 1. **Session Cookies:** they are temporary cookies that are not stored on the user's device, but disappear when the session ends. The information obtained through these cookies is used to analyze web traffic patterns and offer our services through it.
- 2. **Persistent Cookies:** these are cookies stored on the user's device and allow us to recover the browsing information on the next visit. They have an expiry date, but this extends beyond the end of the session. These cookies allow us to customize your visits based on your preferences (eg country and language).

#### **BRIGANTI ADVOGADOS COOKIES:**

Some are strictly necessary, such as those used to correct navigation or recognise user's preferences during their visit to the website. Others are analytical cookies which to collect statistical data on activity.

Cookie	Expiration	Purpose
PHPSESSID	Session	This cookie is a session identifier provided by PHP to differentiate sessions between users
COOKIEBAR_1	1 year	This cookie stores Cookie Policy acceptance information.



#### **THIRD-PARTY COOKIES:**

Third-party cookies, such as those used for identification or by external content add-ons, such as the Google search system.

Cookie	Expiration	Purpose
_ga	2 years	Cookies used by Google Analytics for statistical access control.
